

# BLUE JORDAN FOREST OWNERS' ASSOCIATION Board of Directors Meeting Minutes Sep 14, 2016

#### 1. Call to Order:

**Director Cutts** called the meeting to order at 6:30 p.m. at Jim Gorman's Barn – 2918 Indian Pipes Trail.

#### 2. Roll Call:

#### 4. Approval of Minutes:

The Board of Director's received an electronic draft copy prior to the meeting. A motion was made by Director Scroggins to accept the minutes as received. Director Kleckner seconded the motion. All of the Directors present voted unanimously.

#### 5. Monthly Financial Report / Treasurer's Report: Director Scroggins:

Deposits for August were \$3,083.62. Expenses were \$8,651.44, with a balance of \$12,031.61\_as of August 31, 2016. As of September 1-14, 2016 deposits were \$1,600. Expenses were \$3,395.10 leaving a balance of \$10,236.51.

**Reserve Account:** The Reserve Account as of September 14, 2016 is \$55,596.78, until the next quarterly deposit. Director Kleckner made a motion to accept the Financial Report as presented. Director Torres seconded the motion. All of the Directors present voted unanimously

**SNAP Collections:** Director Scroggins stated that we have 2 or 3 more properties paid off. Start reviewing any new past due accounts.

## 6. Presidents Report: Glenn Cutts

- -- V.P. Cutts introduced BJF new board member Edwardo Torres,
- -- He also announced that a director's position was open. Dianna Gross and Carol Ayres offered to submit a resume to the Board for their review.
- -- Gates on Sand Pine and R.E.Byrd Rd. needed repair on several occasion

- -- Roads are in desperate need of attention. V.P. Cutts offered to use his personal grader at no cost to BJF. A discussion took place stating the need for multiple loads of shell rock necessary to build up the road base. Crowning of the roads can only be accomplished by using a grader
- -- Refuse site is in relative good shape.

- -- Volunteers: Director Kleckner, the total volunteer hours this year are 973 hours

#### 8 Community Chair Reports:

- -- <u>Building Committee</u>: Don Laycock: Hobson has about 2 hours of work left, then we need an as built survey. County inspection for of site work and a sign off for the building.
- -- <u>Architectural and landscape</u>: Don Laycock: reported that the owners of Lot 177 at 2860 Indian Pipes Trl. Are Ed & Jean Speir. They have met with the building committee and have approval to build on their lot. A new custom build modular home being built. Permits are in process.

Possible buyers for Lot 166 have contacted the building committee for information on BJF rules and regulations.

The new owner Paul Guasto of lot 156 on 2478 Sand Pine contacted the building committee to ask if he could put shell rock on his driveway so he could access his property. We approved but stated if a culvert pipe had to be installed we must approve it before installing. No building at this time.
